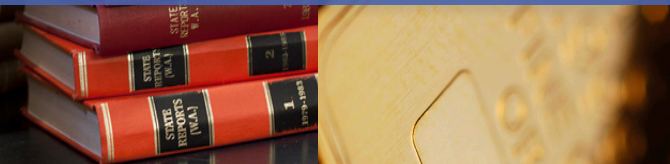

Course structure and study options

The courses consist of either 24 credit points (GradDip) or 48 credit points (Masters). Study can be undertaken either full-time or part-time. Students can commence their studies by enrolling in the GradDip and providing they attain a weighted average mark of at least 60%, articulate into the Masters.

Graduate Diploma of Commercial and Resources Law

Graduate Diploma students elect three of the following 6 point units listed below:

- Australian Oil and Gas Law
- Climate Change Law and Emissions Trading
- Corporate Governance for Resource Companies
- Environmental Protection Law
- International Environmental Law
- International Oil and Gas Law
- Mining Law
- Oil and Gas Agreements
- Oil and Gas Project Development Law
- Water Resources Law

Students also select a unit to the value of 6 points from the Master of Laws (LLM), which include:

- International Commercial Arbitration
- Corporate Finance and Securities Regulation
- Comparative Law
- International Trade Law
- Alternative Dispute Resolution
- Insurance Law
- Research Paper

Master of Commercial and Resources Law

Masters students elect six of the listed 6 point Graduate Diploma units and an additional two 6 point units from the Master of Laws (LLM).

Admission requirements (GradDip)

- a Bachelor of Laws of this University or equivalent, as recognised by the Faculty
- a bachelor's degree in another relevant subject area as determined by the Faculty, and completed to a level of competency considered by the Faculty to be sufficient to permit satisfactory completion of the course; or
- a level and duration of education as well as a minimum of two years of professional experience considered by the Faculty to be sufficient to permit satisfactory completion of the course.

Admission requirements (Masters)

- a Bachelor of Laws of this University or equivalent, as recognised by the faculty
- completed all the units for the GradDip in Commercial and Resources Law of this University with a weighted average mark of at least 60%; or
- a bachelor's degree with honours in another subject area requiring at least four years of full-time study, or equivalent as recognised by the Faculty.
